Principal's report. The Principal's report had been circulated to the Board via the shared drive prior to the meeting. As attached.

Ryan presented his report to the Board.

We will be up over 140 for this year with pre enrolments for next year. Looking like we will hold on to most of our Year 6 students at the end of this year. We are looking at potentially only losing around 10 students (Year 6, 8 and children).

NAG 1 Curriculum: Year 7 & 8 students hosted a group from Age Concern as part of the leadership programme. This went very well and they are looking forward to another session. They have been teaching them to knit and play games. Great conversations happening in the classroom. One of the ladies is turning 100 in September and the kids are keen to do something special for her.

NAG 2 Self Review: Nothing to report.

NAG 3 Personnel: Once staffing confirmation is received Ryan will be advertising the Full time Senior and Junior teaching positions for 2025.

NAG 4: Finance and Property: Part one of the re roofing project has been completed. The staffroom and part of the office block has been done. The remainder will be done in the term 3 - 4 holidays.

NAG 5: Health and Safety: Annual Alarm Maintenance has been completed.

Earthquake and Fire emergency drills completed.

One young child split his head open on a bag hook. No sharp edges. They are at a height for 5 year olds, not enough room for cubby holes. Suggestion to glue a rubber ball on the end of each hook. Ryan will look into this. (2)

NAG 6: Legislation: The government has unveiled their Make It Count Programme for Maths. This is initially to address the poor results from Year 8 student testing nationwide. Ryan wants to give some context. These are 2021 results from 42 schools, 800 kids and it is something that hadn't been taught to them. This means that the results are not really accurate as to where the kids are at only proving what they don't know yet.

They are bringing in 2 x yearly assessments. Small group interventions. Raising the required achievement to level 2 NCEA for teachers to have achieved. These are positive steps.

The speed that this is happening is causing extreme concern, the draft came out today and is incomplete. 95 page document is under consultation until the end of September. To be implemented next year:

Still no acknowledgement, allowance or funding to address special social and development needs of children currently. Will there be enough funding to run it now as well as in 4 - 5 years time? Craig asked what extra in support the teachers and Ryan may need? Time essentially. It needs to be understood first, then planning, then assessment, then placing the children in the correct levels. The COL will be involved as well, we will tag into anything that comes through. There are lots of questions coming in, we need answers.

Other: A celebration breakfast was held the first day of Term 3 to welcome in our new teaching staff. Well attended by parents and community members.

A Board and Staff get together was held at Scott's and was a great opportunity for Board and Staff to connect with each other.
